This year, new Marine Protection Rules came into force, targeted to reduce emissions from vessels that operate in the sea. The rules are part of New Zealand's accession to MARPOL Annex VI an international agreement that aims to reduce air pollution from ships.

Alison Barrett and Daniel Kinder of Maritime New Zealand will be presenting on the Annex VI implementation and the new Part 199 Marine Protection Rules.
